This Office has received your FOIA request dated January 4, 2024, which seeks:

For the **candidate disclosures of Michael A. Wilson for the position of AG**, please provide the following information in accordance with this FOIA request at your earliest convenience:

1 - All documentation from 1-1-21 to present day related to contributions from and payments (including those returned) to JENNIFER or ROXANNE or ANNA GRACE or JOE or ALAN or MICHAEL WILSON to include, but not be limited to bank statements, cancelled checks, and the like.

2 - All documentation from 1-1-21 to present day related to contributions from and payments (including those returned) to LJA, LLC to include, but not be limited to bank statements, cancelled checks, and the like.

3 - All documentation from 1-1-21 to present day related to contributions from and payments (including those returned) to **FIRST COMMUNITY BANK** to include, but not be limited to bank statements, cancelled checks, and the like.

4 - All documentation from 1-1-21 to present day related to contributions from and payments (including those returned) to **SC Conservative Action Fund** to include, but not be limited to bank statements, cancelled checks, and the like.

5 - All itemized invoices from **Southern Way Catering** and a copy of all payments to this business since 1.1.22.

6 - List of all donors and corresponding amounts related to the receipt of **ALL CONTRIBUTIONS RECEIVED** at the August 2023 PARTY at Williams- Brice.

7 - The **guest list and RSVPs for the August 2023 party** at Williams Brice Stadium.

For the **OFFICE OF THE ATTORNEY GENERAL** please provide the following information in accordance with this FOIA request at your earliest convenience:

8- Any and all documentation for the findings related to the **DISCREPANCIES INDICATED IN THE COMPOSITE RESERVOIR ACCOUNTS** as outlined in the June 2023 OSA report, pages 4 and 5; this should include, but not necessarily be limited to any corrective action, action plans, QA reports, internal audits and the like that has occurred since the time the deficiencies were identified.

Also, this Office has received your additional FOIA request dated January 11, 2024, which seeks:

(1) **Delta Air Travel** indicated as a campaign expenditure on December 22, 2023 for **\$1996.80** to include the parties for whom the air travel was purchased, the itinerary, and the type of seat purchased (coach, business, etc.).

(2) The transaction indicated as a **loan for \$2928.94**, please provide details to whom or what entity, for what purpose, and when authorized.

Pursuant to your request, the records of the Office were searched, and the responsive documents we located are attached.

Please be advised that most of the items you requested are not public records prepared, owned, used, in the possession of, or retained by the Office of the South Carolina Attorney General.
